### 1. Why should I contribute now?

### 2. How much should I contribute?

### Suggested INR tiers:

1. **The Torchbearer – Rs 90,000** Example Cause: Community Pillars Fund
2. **The Dream Launcher – Rs 1,50,000** Example Cause: Entrepreneurship Grant.
3. **The Game Changer – Rs 3,00,000** Example Cause: Future Women Leaders Scholarship
4. **The Momentum Builder – Rs 6,00,000** Eg Cause: Entrepreneurship Grant + Women Leaders Scholarship. 5.
5. **The Legacy Architect – Rs 12,00,000+** Eg Cause: Community Pillars + Women Leaders Scholarship

### Suggested USD Tiers:

1. **The Venture Spark – \$2,000** 🚀 Example Cause: Entrepreneurship Grant
2. **The Education Catalyst – \$3,600** 🎓 Example Cause: Future Women Leaders Scholarship
3. **The Community Beacon – \$5,000** 🏠 Example Cause: Future Women Leaders Scholarship + Community Pillars Fund
4. **The Innovation Amplifier – \$8,000** ⚡ Example Cause: Entrepreneurship Grant + Future Women Leaders Scholarship
5. **The Millennium Benefactor – \$20,000+** 🏛️ Example Cause: All Three Initiatives

### 3. Who will manage the money? How do we know it has been spent well?

The funds collected from us will be managed by BITS Pilani Alumni Relations Division (BITS ARD). **BITS ARD has established compliance and reporting systems** to manage funding from domestic and global alumni. They are the custodians for funds collected from other batches as well. The representatives from our batch will follow up with BITS ARD to ensure that the funds we collected are indeed used to support the causes that we have chosen as well as ensure regular engagement with donors to report updates.

### 4. BITS is already flush with funds. Do we really need to contribute more?

While there are many opportunities for alumni to support BITS' institutional needs, the organizing team consciously proposed to support the students, who are in most need of the funds, rather than the infrastructure needs of the campus. This was in part because, given the size of the fund, it will have more meaningful value in helping the students who don't have the financial means today than the campus infrastructure itself.

We wish to also highlight that the IITs have been fundraising from alumni through formal channels for a while now with some high profile contributions in spite of obtaining thousands of crores in government funding. BITS Pilani 4-year Term fee is significantly higher than IITs, and many underprivileged students are forced to give their seats up due to the high tuition fee. Our Funds will ensure its all well taken care of.

### 5. Can a non-BITSIAN contribute to our Batch Endowment Fund?

## **6. Can my company contribute to our Batch Endowment Fund?**

BITSAA is a registered entity and can receive philanthropic funding from companies. We encourage all of you to engage your company leadership and CSR counterparts to see if they would be interested in contributing to the cause.

Companies can support by:

- Setting up a matching grant to support the funding raised from the Alumni.
- Encouraging employee volunteers to contribute to the fund, even if non-BITSIANS.

## **8. From which countries are donations tax deductible?**

## **9. How do I get my tax exemption certificates once I have made a contribution?**

All the donations made to BITS Pilani will be 100% tax deductible under section 80G (2)(a)(iiif) of Income-tax Act, 1961. **10. I am making my donation through my company. How can I get BITS Pilani's 80g authorization certificate which it would have received from the IT Dept? This will be needed to ensure that my company receives 100% tax exemption?**

### **12. Is there an end date by which we need to raise the fund?**

There is no explicit end date. We plan to hand over a cheque to the Institute at the Reunion in Nov, 2025 (whatever is collected till Nov, 2025). However, in order to start to deploy the funds towards the initiatives in 2025, our ambition is to achieve our fund goals by Feb 2026.

### **13. Are AMEX credit cards accepted on the INR Donation page?**

No, AMEX cards are not accepted on the INR Donation page.

### **14. Will credit cards be charged extra on the Donation page?**

Credit cards might just be charged extra. However the extra amount should always be reflected on the payment gateway before the final OTP. So, you would know if you are being charged a processing fee.

### **15. What if the donor is in the USA and is a citizen of India? Can he donate in INR?**

Donor is a citizen of India holding Indian passport on the date of receipt of donation by the Society

If the donor is a citizen of India (holding Indian Passport though living in other foreign country), the donation made by such donor from his/her personal savings through normal banking channels (from his/her NRE / NRO account in India in INR or from his / her foreign bank account in foreign currency) to the Society is not a “foreign contribution” as defined in S. 2(h) of Foreign Contribution (Regulation) Act, 2010 (FCRA 2010). Such donor is not a “foreign source” as defined S. 2 (j) of the FCRA 2010 till the donor continues to be Citizen of India. The Society shall receive such donation in its non-FCRA bank account.

### **16. What if the donor is a citizen of a foreign country (holding foreign passport)?**

If the donor is a citizen of foreign country, the donation received from such donor's NRE / NRO account in India or from donor's foreign bank account in foreign currency by the Society is "foreign contribution" as defined in S. 2(h) of Foreign Contribution (Regulation) Act, 2010 (FCRA 2010) which shall be received by the Society in its designated FCRA Bank Account with SBI. Such donor is "foreign source" as defined S. 2 (j) of the FCRA 2010.

**17. What docs need to be submitted to get a Tax certificate by a foreign donor?**

Also, for any foreign donations - Passport copy, email id, phone no. and a foreign address to be mailed to [alumnirelations@pilani.bits-pilani.ac.in](mailto:alumnirelations@pilani.bits-pilani.ac.in) to get a tax certificate.
