Responsibilities for 'Data Protection' include: DPDP Act Compliance: Ensure compliance with the Digital Personal Data Protection Act, 2023, and other legislations on data protection with a focus on secure handling of employee and institutional data. Conducting data privacy audits, impact assessments, and implementing remedial actions. Collaborating with the legal, IT, and compliance teams to update processes and policies. Providing training and awareness programs on data privacy for staff and students. Managing and responding to data subject access requests. Handling breaches of personally identifiable information (PII) and coordinating with relevant authorities. Developing and implementing the institute's data protection strategy, policies, and procedures. Advising on data protection aspects of new IT systems and procedures. Responsibilities as a 'Compliance Officer' include: Labor Law Compliance (The Employees' Provident Funds and Miscellaneous Provisions Act, 1952; The Shops and Establishments Act, 1948; The Industrial Disputes Act, 1947; The Payment of Wages Act, 1936; Building and Other Construction Workers Act; Any other relevant state and central labor laws, etc.) Regulatory Compliance Policies, guidelines, rules and regulations promulgated by MoE, UGC, AICTE, PCI, BCI, IoE, Public Trust, Section 8 Company, Society, etc. and Audits Statutory Compliance — Environmental, Safety, Pollution, Fire, Construction, etc.
